## Broadway UMC Ministry Advocates, Chicago

The Ministry Board of Broadway United Methodist Church has the responsibility to guide the life of the organizational church and to provide both support and accountability to the pastor as the pastor leads the congregation in fulfilling the mission of the church in “making disciples of Jesus Christ for the transformation of the world” and the mission of Broadway which is as follows-

“God calls Broadway United Methodist Church to be a faith community embracing the diversity of our Chicago neighborhood and larger community. We welcome all persons- celebrating the human family’s God-given diversity of race, age, gender, sexual orientation, and physical or mental capacity. We also welcome persons of all social and economic classes and faith backgrounds. At Broadway, we are accepted into God’s nurturing family, which invites us into spiritual growth through worship, study, mission, and social action. We are grateful for the opportunities God gives us to experience and share the love of Christ.”

## **The roles and responsibilities of the Broadway Ministry Advocates:**

- Develop its style of operating and set the organizational direction for the church.
- Establish evaluation and accountability structures.
- Establish policies for the effective, healthy functioning of the church.
- Work with the pastor to fulfill established annual goals, keeping the church on course, and moving in the direction set by the Board. Hold each other accountable for our part of fulfilling the mission of the church.
- Collaborate with Money Ministries to approve the annual budget and submit it to the congregation.
- Approve all major facility construction, renovations, and repairs of the existing facility. Minor day to day issues will be managed by the Property Caregivers team.
- Address any legal obligations and decisions that affect the congregation as a whole.
- Work with congregation to form ad-hoc (temporary) task forces or subcommittees consisting of members of the Board, qualified members, and/or friends of the church for special projects as needed.
- Maintain all records and documentation on the work of the Board.

## **Term Guidelines**

- Each committee, caucus group and ministry team has appointed a member to the council (pending new name). Those currently appointed will serve through August 31, 2017 as we organize the group, lay the groundwork, and decide on policies and procedures.
- During the month of August 2017, each committee, caucus group or ministry team will officially select a representative for the council.
- Those selected will begin service on September 1, 2017. Half of the group will serve a one year term, and half a two year term.
- Going forward, groups whose terms are expiring will select a new representative before September 1.
- Representatives may only serve two consecutive terms.
