Self-screening Questions

- ⇒ *Have you had a body temperature over 100 degrees Fahrenheit or have you used a fever reducer in the previous 24 hours to treat a body temperature over 100 degrees Fahrenheit?*
- ⇒ *Do you have cough that you cannot attribute to another health condition?*
- ⇒ *Do you have a new or worsening sore throat that you cannot attribute to another health condition?*
- ⇒ *Do you have new shortness of breath that you cannot attribute to another health condition?*
- ⇒ *Have you recently developed a complete loss of smell or taste?*
- ⇒ Have you recently been in contact with someone who tested positive for COVID
- ⇒ Have you recently been diagnosed positive for COVID?

If your answer to any of the questions is YES, then we suggest you stay home, take care of you and contact your doctor if necessary.

Guidelines

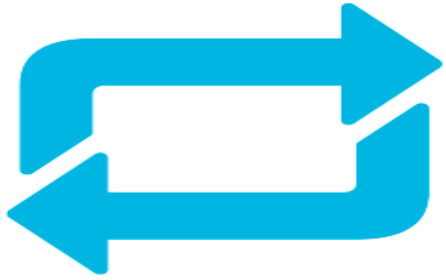
- ⇒ Vulnerable individuals continue to shelter in place.
- ⇒ Gatherings of up to 10 people allowed.
- ⇒ Mask is required to be in the building.
- ⇒ Social distance is to be maintained.

Worship

- ⇒ On line only.
- ⇒ Fellowship after worship is also offered on-line.
- ⇒ Pastoral care is provided virtually.

Building Use

- ⇒ No groups or committees are meeting in the building.
- ⇒ Office Manager is in the building once a week.
- ⇒ Director of Music Ministry is in the building once a week.
- ⇒ Pastor is in the building once a week.
- ⇒ Staff is in the building as needed.



Phase B (Phase 3 by IDPH guidelines)

TENTATIVELY July 15th for Broadway building

Guidelines

- ⇒ Gatherings of up to 25 people are allowed.
- ⇒ Mask is required to be in the building– *disposable masks will be provided if needed.*
- ⇒ Social distance will be maintained.
- ⇒ Temperature will be taken at the door.
- ⇒ No one who is sick will be allowed in the building.
- ⇒ No food/drink will be allowed in the building.
- ⇒ There will be one entrance and exit (both marked).
- ⇒ Sanitizer will be available at both entrance and exit.
- ⇒ Sanitize the room when you enter and before you leave.
- ⇒ Nursery care will not be available.
- ⇒ Bathroom use will be limited to one person at a time.
- ⇒ Bathrooms doors will stay propped open.

Worship

- ⇒ Worship will continue to be offered on-line.
- ⇒ Worship leaders and pastor may lead it from the building.
- ⇒ No communion will be served.
- ⇒ No Fellowship in the building (after worship will only be offered on-line.
- ⇒ Pastoral care is provided virtually.

Building Use

- ⇒ Groups of 25 or less will be allowed to meet in the building.
- ⇒ Office Manager is in the building once a week.
- ⇒ Director of Music Ministry is in the building once a week.
- ⇒ Pastor is in the building once a week.
- ⇒ Staff is in the building as needed.



Phase C (Phase 4 by IDPH guidelines)

TENTATIVELY August 1st for Broadway

Guidelines

- ⇒ Gatherings of up to 50 people are allowed.
- ⇒ Mask is required to be in the building– *disposable masks will be provided if needed.*
- ⇒ Social distance will be maintained.
- ⇒ Temperature will be taken at the door.
- ⇒ No one who is sick will be allowed in the building.
- ⇒ No food/drink will be allowed in the building.
- ⇒ There will be one entrance and exit (both marked).
- ⇒ Sanitizer will be available at both entrance and exit
- ⇒ Sanitize the room when you enter and before you leave.
- ⇒ Nursery care will not be available.
- ⇒ Bathroom use will be limited to one person at a time.
- ⇒ Bathrooms doors will stay propped open.

Phase E

When a Vaccine is Available

When we HAVE A VACCINE and it is available to ALL people,
the in-person activities at Broadway will resume!

**Current estimation for the vaccine to be
available to all people is in 2021**

Question you may ask:

- ◆ What if someone who comes to worship/meeting tests positive for COVID?
We will inform all who were in the building during that gathering while maintaining confidentiality of personal information.
- ◆ Will the building be cleaned and sanitized after every use?
We request each group to clean/sanitize the room before they start the meeting and before they leave the room. *We will not be able to have the room sanitized by our cleaning service after every use.*
- ◆ What if we see a resurgence of COVID-19 cases?
We will review our plans immediately and if needed follow the IDPH and/or City of Chicago guidelines.



Checklist

For Internal Use Only

- Signs are posted
- Hand Sanitizer dispensers are in place
- Monitors are informed
- Thermometers are tested
- Hand dryers are disabled
- Paper towels are placed
- Garbage receptacle is placed outside the restrooms
- Masks are placed
- 6 feet distance markers are made in every room
- Signs are posted to “Entrance” and “Exit”
- Room sanitizer spray is placed in every room
- 6 feet markers are placed on entrance ramp
