Report of the Pastor 2021 Rev. Alka Lyall

On July, 2021 I started my 6th year at Broadway. We have gone through much these past years-leadership and membership changes, a pandemic that we continue to live with it- trying to manage it as best as we can. We continue to live with the uncertainty of where the United Methodist denomination will be in the future, with the General Conference (the decision-making body of the denomination) continuing to be postponed due the pandemic.

And, in the midst of the epidemic and these uncertainties, we have felt blessed! Here are some of the highlights of our past year-

- We started hybrid worship in November which has started really well- thanks to our faithful volunteer team of techies- Dylan, Rebecca and Woo.
- Some of our building users have returned to the building.
- We hosted vaccination clinic in our building.
- Our long-term building partners have continued to be generous with their financial decisions,
- Our racial justice fence continued to be a positive presence in the community- several community
 members offered to help us with reposting the pictures (of BIPoC persons killed by police or mass
 hate crimes against BIPoC) of the fence, when ever we lost them to a storm or another angry
 community member.
- We had put up a mitten tree outside our church this past year because of COVID (generally it is
 inside the building). That attracted large community response- the tree remained full into January.
 We decided to replace the tree with large tote boxes as 'community clothes closet,' following the
 honor system. The community responded generously. We were able to help many community
 members in this way.
- Our food pantry has been a tremendous help in this past year. We continue to have a hard time
 keeping the pantry stocked! Community members have been generous in their donations but the
 need has grown tremendously in this past year.
- We are blessed with 2 pastoral interns this year- one from the Chicago Theological School, and another from the Meadville Lombard Theological School.
- We have resumed offering worship at a neighborhood Senior Living Facility (Brookdale) this year.
- We had 2 school pods in our building most of last year which helped us financially and provided a space for the 1st and 3rd graders to have some sense of learning with peers.
- We received 1 new member by profession of faith, and baptized the twins of our newer members who had joined the church in early 2020 but we couldn't get their kids baptized before COVID.
- Our younger adults have been stepping up to the plate and taking many responsibilities!

 Our financial health continues to be a challenge for us, which now is complicated with the up-coming life changes in some faithful members of our community. We pray and hope that God will open a way for us that will help us keep our doors open and continue to be a witness here in the community of Lakeview. With everything we have been through we have seen the resiliency of this community, and experienced the faithfulness of God. I have celebrated the commitment the members of Broadway UMC have



towards their church, and I am grateful for every one of them. I am grateful for the opportunity to pastor this community of God's beloved- who keep working toward being a safe space for all persons and continues to teach me to live authentically. I will continue to serve with these faithful people of Broadway as long as God desires, and the Bishop and cabinet choose to keep me here. Standing on the side of justice I am

My primary place of ministry, enfleshed, is going smoothly. This year, I've been particularly excited to work on a book enfleshed is publishing called "HELD: blessings for the depths." After months and months of layout and editing and curating and creating, we eagerly anticipate its arrival this month. enfleshed continues to provide liberation-oriented liturgy and worship prep materials to hundreds of clergy across the U.S. and in Columbia, New Zealand, Canada, and elsewhere. This past year has brought a much needed shift toward a collective of writers for that work, expanding perspectives well beyond my own. This brings me deep joy! It has also enabled me to put my focus on other aspects of ministry, nonprofit admin, and writing that reflect my growing interest in spiritually nourishing those who do not find themselves solidly within any religious or spiritual tradition or community.

One of my favorite things about my place of ministry is the variety of opportunities it holds - a little of this and a little of that! Last month, I facillitated a four-part class on "befriending desire and the eros of God" with queer lutheran clergy. This month, I'll be talking about supporting trans patients with health care workers in Philedelphia, and next month, at the annual assembly of Hospice and Palliative Care. While my partner and I are still living as COVID-conscious as we can, still staying home to a significant degree, it's been a delight to be in shared virtual community spaces of many kinds.

Meanwhile, this past April, I began a two year certificate program in Spiritual Direction. I am looking forward to providing witness and companionship to people at an individual level. This intimate form of ministry appeals to me in this season of my vocation.

I am giving thanks for the ongoing support of Broadway, sending all my appreciation and care, and looking forward to the day I can visit for worship once again.

Property Care Report 2021 Charolette Lill, Property Caregivers Co-Chair

First, throughout the months of the pandemic in 2020 and 2021 there were many volunteer hours of painting done by our pastor Alka, her son Abe and some caring parishioners. Because of their generous time, nearly all the interior walls of the church were painted with new room signage installed. Our thanks to them.

Despite the fact that for most of 2021 we did not have in-house worship services, the church building was still being used. There were two groups of school children using space for class from 9/20-5/21 since the public schools were not open. In addition our pastor was very busy keeping everyone in touch and overseeing the virtual services which were staged in the church sanctuary. Therefore, cleaning services, electric and gas and snow removal expenses continued.

There were other costs such as fence, church doors and church AC repairs. During the AC repair we learned that the AC unit on the church roof was beyond repair. Estimates were received for a new unit and the amount is almost 10K for a replacement. We have not proceeded with that purchase. It was also determined that we had not had a complete check of the furnaces or water heaters for a long time so that service was ordered and completed in August. During this check it was learned that one of the five furnaces needed major repair, such that getting a new one was a better decision. This new furnace was installed on Nov. 15.

A new stove for the parsonage was needed and purchased early in the summer. At the time of installation it was decided to redo the kitchen wall tiles and upgrade a bit. The parsonage also had a new water heater so it was not necessary to do a summer check but the furnace was checked. The parsonage had experienced water backup in the basement drains at times of heavy rains. Sewer service was called and all drains have been rodded and cleared of tree roots and debris. There has also been some major clean out of the parsonage basement area which Alka has overseen.

For several of the jobs and purchases listed above there have been generous donations from a few parishioners. While these gifts are greatly appreciated, it is my suggestion that there be more communication with the entire church family concerning the needs of the property so that all can participate in some of the special projects.

If we total the amount of the Care given the property this year it comes to about 15K of costs of repairs and new purchases. This does not account for volunteer hours and regular utility expenses. We are privileged and grateful to have a "newer", accessible church building in a prime location in the city, however, here are always ongoing care needs especially as the building and grounds age. For example, repairing and painting all the rod iron fence will be necessary in the next year.
